<b>Black Horse Inn Underground Railroad Museum</b>	<p><b>Project Update: GMP 1: 100% complete, GMP 2: 15% construction complete</b></p> <p>Engineers/architects completed the structural assessment on the collapsed central chimney that paused construction on 12/15. Active construction began again on 1/20 as the CMR shores all the areas of the building indicated in the structural report and began repairs. The structural repairs are to be completed in a month and the additional work will be done within the grant funding period; pushing the substantial completion from 6/30/26 to 8/6/26. Exhibit design was presented to the owners on 1/20 and exhibit fabricators continue work and are on track with the projected invoicing.</p> <p>The fire suppression subcontractor performed their site visit and will be providing the drawings for the permit. Invoices were below the projected amounts due to the pause in construction. The cost of the additional structural and architectural work in Feb/Mar will correct the percentages.
